Equipment Use and Operation

I agree that no other user is authorized to utilize this device. I agree that I will not sub-let, rent, or loan device to another user. I agree that the rental unit will only be used on the following vehicles:

I agree the rental unit will be verified to be working correctly prior to shipment.

I agree the rental equipment is not water resistant, nor waterproof, and at no time will I use it around liquids nor will I use liquids around the unit.

I agree that the equipment rental does not include technical support from Lean 6 Innovations for my vehicle and that all usage of the rental equipment on my vehicle is my sole responsibility.

I agree that the rental unit will be delivered with a protective film installed over the screen and that I will not remove or damage the film and that any removal or damage to the film may result in forfeiture of my deposit. I agree that the rental unit will include a stylus for use with the touch screen and that I will only use the stylus for operation of the touch screen.

Deposit and Equipment Return

I agree to provide a \$550 refundable deposit for the rental of the unit as part of the initial charge.

I agree to have any additional rental charges due to late return of the equipment deducted from my deposit with the balance returned to me minus the additional rental charges.

I understand that if I do not provide photos of the package and equipment condition and contact Lean 6 Innovations upon receipt of unit if I see any damage or if the unit does not respond correctly to user input I am accepting the responsibility for the unit being in excellent functional and cosmetic condition upon receipt.

I agree that the rental equipment including Nanocom S/N 20546, OBD cable, metal screen cover, and stylus will be delivered inside the manufacturers original packaging and that I will return it installed in the same original packaging exactly as delivered. I agree that the original manufacturers packaging will be delivered inside a water tight ziplock bag fully sealed with dessicant packets included and that I will return it installed in the same water tight ziplock bag fully sealed with dessicant packets included. I agree failure to do so may result in forfeiture of my deposit at the sole discretion of Lean 6 Innovations.

I agree that any damage to the unit from liquids can only occur during my use outside of the shipping packaging and may result in forfeiture of my deposit at the sole discretion of Lean 6 Innovations.

I agree that I will create a video record of the following on the Monday morning of the return shipment date:

1. The unit operating screen followed by operational shutdown,
2. Disconnecting and placing the unit in the original packaging,
3. placing the packaging inside the FedEx package and sealing the package.
4. All of the preceding will be recorded continuously with no gaps or pause in the video recording.

I agree the video record is necessary for the return of my deposit and failure to do so may result in the complete forfeiture of my deposit if the unit does not arrive at Lean 6 Innovations in functioning condition. The purpose of this is to substantiate functional condition at the time of placing in the package for any shipping claims in the case of any return shipping damage.

I agree that I assume all responsibility for securing a drop receipt for the FedEx package showing proof of shipment and will forward that receipt to Lean 6 Innovations for package shipping insurance claim purposes. I agree that failure to do so will result in my deposit being forfeited if the unit is lost in transit.

I agree that my deposit will be returned only after Lean 6 Innovations has received the unit, inspected it for acceptable return condition, and tested functionality to assure no shipping damage has occurred.

I agree to assist Lean 6 Innovations in any manner deemed necessary to the satisfaction of Lean 6 Innovations to complete shipping claims related to a rental unit lost or damaged during shipment to or from my location prior to return of my deposit.

I agree that my \$550 deposit will be forfeited upon failure to return rental equipment per the conditions agreed to in the above paragraphs or within 10 weeks of scheduled return date.

Rental Period:

I understand that the rental unit will be shipped to me on a Monday via FedEx OneRate 3day service using a FedEx Pak and will arrive not later than 8:00pm on the following Thursday.

I agree that I will utilize the equipment and return ship the unit via the provided FedEx OneRate shipping label and FedEx Pak not later than the following Monday.

I agree that it is my sole responsibility to deliver the unit to a FedEx pickup location before the daily pickup on the above mentioned following Monday.

I agree it is my sole responsibility to contact the drop location and determine the pickup time and assure I have dropped the unit before that time.

I agree that missing the assigned Monday ship date will result in an additional week rental charge of \$55 per Monday with no pro-rating for partial weeks.
